# **Candidate Statement**

I have been honored to serve as the national APHON treasurer since 2020. Continuing in this role for an additional term will provide stability for the Board during a time of rebuilding. I accepted a 1-year appointed term in 2020 as the treasurer at that time transitioned to the President-elect role. I was elected to my first official term in 2021. My time on the Board has included the challenges associated with the pandemic, and most recently the transition to a new management company. The decision to

transition carried risk, but as a board member, I strongly supported the need to do so from a financial standpoint as well as the future welfare of the organization. Transition brings challenge, and we knew the initial goal was to stabilize the organization before focusing on growth. While we are still working on stabilization, I am optimistic that this remains the right decision and we will eventually begin growing.

Strategic planning this year will require decision-making around enhanced revenue opportunities and careful review of the return on investment of current and future initiatives. We are currently creating an investment policy for future guidance on how investment decisions are made. Transition to a new company has opened awareness of the need for more structure in the operational and financial infrastructure of APHON. My experience over the past 4 years as well as my leadership experience in my professional roles would provide consistency to the Board as we work towards the long-term goal of growth.
